Greetings from Sue-Kyong ("Sue") Shin Vittas, President of the KOWIN DC



Dear KOWIN DC Members and Friends.

It is hard to believe we are already half way through the summer. I hope this newsletter finds all of you and your family in good health and enjoying the summer.

Since the New Year in 2016, we held the KOWIN DC winter re-

treat in Lake Anna in Virginia at the end of February where we held our first quarterly regular meeting and had a chance to plan ahead all the activities for the rest of the year.

In April, we prepared and submitted to the KOWINNER Foundation two grant project proposals; the leadership seminar on "Preparing to Face Global Career Challenges" and the webinar on "Wartime Atrocity Against Women During WWII; Case Study of Comfort Women and Other Victims of Human Trafficking" in the hope of receiving some funding for these projects, but have not heard anything yet. Irrespective of how much (or how little or if any) we receive, we still have to hold the leadership seminar event. We have now assembled a new team of seminar committee members and already held the first meeting in preparation for the upcoming seminar which is scheduled for Saturday, November 12.

In May, ten KOWIN DC members submitted applications to Ministry of Equal Gender and Family (MOEGF) to attend the KOWIN Convention to be held in Jeju island from August 23-26, and all ten of us have been accepted to participate in the Convention. In the past years, one or two members had to drop out from attending at the last minute due to business or personal emergencies, so we are hoping that all of us can go this year.

The second quarterly meeting combined with the fundraising consignment sale event was held in Annapolis on June 18. We raised approximately \$1,700, but still a substantial amount will be required to carry out the remaining KOWIN events, in particular the leadership seminar. As you all are aware, membership fees are our primary source of funding in maintaining and carrying out KOWIN DC activities. The \$120 annual membership fee is due by the first of each year. Our KOWIN DC bylaws dictate that unless a member writes to the KOWIN president for withdrawal, members have the obligation to comply with the membership dues. The withdrawal notice (email will do) must be sent before the year is over in order to avoid the dues the following year. For example, unless you send a withdrawal notice by December 31, 2016, you are liable for the dues for 2017 which are due by January1, 2017. I hope everyone is informed of this guideline in our bylaws. If you have not yet paid, I ask that you please mail:



2016 First Regular Meeting

February 27, 2016



The first regular meeting of 2016 was held during the KOWIN DC winter retreat at Lake Anna (199 Emma Jane Lane, Bumpass, VA 23024) on Saturday, February 27 with 11 members in attendance.

On behalf of our Treasurer, Junghee Lee, Anne Jelly gave the Treasurer's Report. The current balance as of December 31, 2015 is \$3,601.08 (with total revenues of \$19,435.29 and total expenses of \$15,834.81 since Jan 1, 2015). Our main source of revenue is from membership fees and the payments for the Seminar, quarterly meetings, and salary for our KOWIN Fellow accounted for most of the expenses.

During the meeting many future KOWIN DC activities were discussed. First in discussion was about the leadership seminar which will take place in mid-November. The leadership seminar format will be modified somewhat to give more weight to the area of international organizations and relations in response to greater interest shown by Seminar participants in the previous couple of years. Sue Vittas and Lucy Nam will serve as Co-Chairs for the upcoming Seminar and they asked any members to volunteer to step up to be involved in the preparation of the event.

Second in discussion was about the Holiday Gala. The members agreed to host the Holiday Gala combined with a Silent Auction event sometime in December because we have not had any since the last May Banquet during the KOWINNER Convention. The possible date (either Saturday, December 3 (1st choice) or Sunday, December 4 (2nd choice)) and the venue choice (either Congressional Country Club (1st choice) and Cosmos Club (2nd choice)) were discussed. More details will be announced as the venue and date are finalized. Judy Kim and Paula Park will serve as Co-Chairs for our December Banquet.

Next, Jung Hee (JH) Lee and Helen Won, Fundraising Committee Chairs, talked about their plan to host a consignment sales event in the near future that would take place at JH Lee's summer home in Annapolis). They encouraged members to take this opportunity to clear out their closets and make money selling their items, purchase something unique and valuable from other members at a great price, and also help raise money for KOWIN DC by donating 25% of the sale price to KOWIN DC.

Sue Vittas distributed the KOWIN DC member directory (a list of the members' names, telephone numbers, and email addresses of all current active members). National Unification Advisory Council







Marina Kim, Helen Won, and I attended the 17th National Unification Advisory Council convention held in Seoul at the Sheraton Grand Walker Hill hotel from May 16 through May 19, 2016. Out of the 15 Councils in USA representing entire parts of the USA, 720 representatives, including 55 representatives from Washington DC Coun-

representing entire parts of the USA, 720 representatives, including 55 representatives from Washington DC Council attended this conference. It was a big convention with approximately 1,300 participants including representatives from Korea.

There were sessions of reporting from each council of their leadership roles in unification related efforts from their respective regions of the past year's programs and planned future efforts. Special presentations and lectures were provided by the Korean officials. The representatives were invited by the Blue House and met with the President Kyun-hye Park who appraised the unification efforts by the USA representatives and requested continued support. There also were opportunity to make site visits to DMZ and other security zones. The photo shows the Washington DC Council members with the President Park at the Blue House.

On May 2nd, 2016, in the Sigur Center at George Washington University, WCCW and GW co-organized the conference on comfort women. The president of WCCW, Julie Jungsil Lee and Jisoo Kim, professor of GW cochaired this event. The conference was a capstone of WCCW Webinar project which has been underway throughout 2016 and the theme of conference was "History Writing for Justice and Reconciliation of Comfort Women Issues. The conference addressed the issues of finding archive, primary sources, and the importance of accurate history writing without revision to recuperate the justice and reconciliation of the victims who were traf-

ficked by the Japanese Imperial Military of WWII. The speakers were Dr. Tomomi Yamaguchi, professor of Sociology & Anthropology at Montana State University whose title was "History Wars and Comfort Women Issue: Revisionism and the Right Wing in Contemporary Japan." The second speaker was Dr. Bonnie Oh, distinguished professor of Korean Studies of Georgetown University presented "Comfort Women Testimonies as Oral History." The third one was Dr. Elizabeth W. Son, an assistant professor in the department of Theatre at Northwestern University and her title was "Performing 'Comfort Women' Histories in Redressive Theatre."
